(ii) In the absence of any CPIO/Appellate Authority being on leave, training etc., the Link Officer concerned or the officer who looks after the charge of the post of the concerned Branch/Division would automatically be CPIO/Appellate Authority, as the case may be, for the allotted work. In the absence of any link officer/alternate arrangement, the Section Officer/Assistant Director dealing with the subject shall act as CPIO in respect of the Section/Unit concerned.

3. ShriSumanChatterjee, Deputy Secretary, Ministry of Power is also designated as Nodal Officer for RTI Act, 2005 in respect of RTI matters of Ministry of Power.
